DESCRIPTION

Questionnaire about the benefits of partnerships on relationship quality and ability to conduct effective collaborative interventions for HCV. The survey assesses benefits, drawbacks, satisfaction; reach, and value.

WHY THIS TOOL MIGHT BE USEFUL FOR COMMUNITY-BASED INTERVENTIONS

- ✓ Assesses the contribution to partnership benefits.

ADMINISTRATION, DESIGN, SCORING and ANALYSIS CONSIDERATIONS

ADMINISTRATION

- This questionnaire should take about 15 minutes to fill out.
- Tell participants why you are using the questionnaire, being clear that it is to evaluate the intervention to help make it better, and not to evaluation or judge them.
- Participation should be voluntary, so tell participants that it is ok if they do not complete the survey, and assure participants that there are no negative consequences if they don't want to complete it. Give them a way to do something else at the same time that is similar to completing the survey so that confidentiality of this decision is protected. (For further information on ethical considerations in carrying out evaluations, see [Ethics Resources](#))
- If used in a group setting, ensure that people feel safe and provide reminders about confidentiality. Ensure no one can see each other's answers (screen or paper), and put completed questionnaires into a sealed envelope.

DESIGN OPTIONS

Measuring change after an intervention: (this is the only option for this tool, because it directly asks about the effect of the intervention):

SCORING and ANALYSIS: for each person:

- ✓ Benefits: Add up the number of "yes" answers to Question 1
- ✓ Drawbacks: Add up the number of "yes" answers to Question 2
- ✓ Satisfaction: Add up the number of "Agree" and "Strongly agree" answers to Question 3
- ✓ Reach: Add up individual answers to Question 4a. Add up individual answers to Question 4b. Add up individual answers to Question 5a. Add up individual answers to Question 5b.
- ✓ Values: Summarize the answers to questions 6 and 7
